Indira Gandhi Delhi Technical University for Women may provide financial assistance as Junior Research Fellow (JRF) / Senior Research Fellow (SRF) to few Full Time Research Scholars registered in the Ph.D Programme. The JRFs/SRFs shall be distributed on the basis of need across all departments.

1.1 Fellowship Eligibility:

Junior Research Fellow(JRF) :A student who satisfies the Minimum Eligibility requirement as per the Ph.D Regulation R 1.2.3 of IGDTUW and has been duly recommended by the Selection Committee to be appointed as Junior Research Fellow (JRF). A student who is a continuing Full Time Research Scholar at IGDTUW and fulfills the Minimum Eligibility requirement of JRF at a later stage is eligible for award of JRF provided DRC finds her Research Progress satisfactory and recommends her case for award of JRF.

Senior Research Fellow : A JRF / a continuing Full Time Research Scholar who fulfills the minimum eligibility requirement of JRF and has 02 years of research experience at IGDTUW is eligible for award of SRF provided Review Committee/ DRC finds her Research Progress satisfactory and recommends her case for award of SRF.

1.2 Fellowship Amount

1.3 Progress Evaluation of JRF/SRF : The award of fellowship shall be reviewed every semester based on the assessment of the Performance Report of the fellow by DRC. The DRC may recommend termination of the Fellowship in case the Performance Report of the Fellow is not found satisfactory consecutively for two semesters.

1.4 Upgradation of JRF to SRF: The progress of the JRF shall be reviewed after two years by the DRC / Review Committee constituted by the Vice Chancellor for consideration of upgradation of fellowship to SRF. The fellow may be given SRF after 2 years if the Review Committee / DRC finds that the fellow has done considerable research progress and

recommends her case for upgradation to SRF. In case the Review Committee / DRC finds the work progress / Performance Report of JRF not satisfactory, the committee can recommend for continuation of the fellow as JRF or can recommend termination of the fellowship. The recommendation of the Review Committee / DRC with subsequent approval by Vice Chancellor shall be the final decision.

1.5 Tenure of Fellowship: The tenure of fellowship is initially for two years under the JRF scheme. Upon expiry of this period, the work of the Fellow will be evaluated by experts. If the research work is found satisfactory, his/her tenure will be extended for a further period of three years under the enhanced emoluments of the Senior Research Fellowship (SRF). In case the work for the first two years is not found satisfactory, an additional year will be given to her for improvement. However, during this period she will be designated as a Junior Research Fellow. In such cases, work will be evaluated again after three years, and if progress is found satisfactory, the Fellow will get two more years under the SRF. Thus, the total period of fellowship (JRF and SRF) is five years and there is no further provision of extension.

1.6 All provisions of prevailing Ph.D. Ordinance/Regulations of IGDTUW shall be applicable on the JRFs/SRFs.

1.7 The JRFs/SRFs must submit a detailed consolidated report of the research work done during the entire period of Fellowship on completion of the tenure / resignation of the Fellowship to the Dean (R&C) at the earliest.

1.8 A JRF/SRF shall be governed by the disciplinary regulations of IGDTUW.

1.9 Sponsored students and students receiving any other financial assistance from any sources would not be eligible for fellowship under the IGDTUW JRF/SRF scheme.

1.10 The stipend of JRF/SRF is exempted from the payment of Income Tax under Section 10(16) of the Income Tax Act, 1961.

2.0 Service Conditions:

2.1 DA and CCA: The JRFs/SRFs will not be entitled to these allowances.

2.2 House Rent Allowance (HRA): JRFs/SRFs may be provided hostel accommodation if available and those residing in accommodation provided by the university will not be eligible for drawing HRA. Wherever provision of hostel accommodation is not possible, HRA may be allowed to the JRFs/SRFs as per the Government norms applicable in the city /location where they are working. The fellowship amount may be taken as basic for calculating the HRA

2.3 Leave and other Entitlement Benefits: The JRFs/ SRFs are eligible only for casual leave. Participation by them in any scientific event/workshop in India or abroad will be treated as 'Duty'. The travel entitlement for JRF /SRF for participation in scientific events/workshops in India will be by 2nd AC by rail. Maternity Leave as per Government of India instructions

issued from time to time would be available to female candidates in both JRF/SRF categories.

All leave record of JRFs/SRFs shall be maintained by the HOD office.

2.4 Bonus and Leave Travel Concessions: JRFs/ SRFs will not be entitled to these allowances.

2.5 Retirement Benefits: JRFs/ SRFs will not be entitled to these benefits.

2.6 The award of JRF/SRF shall not entitle the student to claim any right whatsoever for any job in the institution.

3.0 Obligations of JRF/SRF:

3.1 JRF/SRF shall be required to engage teaching/practical classes at IGDTUW for upto 08 hours /week or any other load assigned by the HOD. In addition, the JRF/SRF shall undertake other academic assignments such as examination, invigilation, evaluation etc.

3.2 The JRF/SRF shall pay the fee as per University norms.

3.3 The JRF/SRF shall mark their regular attendance in their Department.

3.4 The JRF/SRF shall not take any assignment paid or unpaid outside the university.

3.5 The JRF/SRF may present/publish their research work in conferences or standard referred journals. It should be ensured by the JRF/SRF that the assistance provided by IGDTUW is acknowledged in all such presentations/ publications. A copy each of all research papers published by the JRF/SRF must be sent to the office of Dean (R&C) at the end of each semester.

3.6 The JRF must send a detailed consolidated report of the research work done during the entire period of the fellowship on completion of the tenure/resignation of the fellowship through the supervisor/HOD to the office of Dean (R&C). The fellow should submit **NO DUES CERTIFICATE** through the supervisor/HOD after completion of the fellowship.

4.0 Resignation from Fellowship : If a JRF/SRF resigns from the fellowship due to any reasons, the fellowship shall be deemed withdrawn, however she may be allowed to continue as a Full Time Ph.D Scholar on the recommendation of DRC and subsequent approval of Vice Chancellor. The fellow may be allowed to convert to Part Time Research Scholar provided she fulfills the eligibility for conversion to Part Time as per Ph.D regulation R5.3

5.0 Termination of Fellowship

(i) The fellowship shall normally stand terminated on completion of its tenure or from the date the JRF/SRF resigns. The Fellowship may be terminated by the University on the recommendation of the DRC.

- (a) Disciplinary grounds/misconduct/Plagiarism Instance

- (c) Candidate found ineligible for fellowship at any later stage shall deposit the entire fellowship amount claimed by the fellow in the university.
- (iii)** The fellowship will be terminated from the date of submission of thesis for the award of Degree of Ph.D or on completion of fellowship tenure whichever is earlier.
- (iv)** If a JRF/SRF leaves without permission at any time, she shall not be paid the fellowship for the period of her service till such time she gets a No Dues Certificate from the Head of the department.
- (v)** Taking up of any paid assignment by JRF/SRF outside the university at any time in the tenure of fellowship, may lead to the termination of fellowship and the JRF/SRF shall be asked to pay back the entire fellowship amount.
- (vi)** JRF/SRF must settle their claims within one year of leaving the Fellowship. No claim will be admitted by University after one year of leaving the Fellowship.

A student who is a continuing Full Time Research Scholar at IGDTUW and fulfills the Minimum Eligibility requirement of JRF at a later stage is eligible for award of JRF provided DRC finds her Research Progress satisfactory and recommends her case for award of JRF.

Senior Research Fellow : A JRF / a continuing Full Time Research Scholar who fulfills the minimum eligibility requirement of JRF and has 02 years of research experience at IGDTUW is eligible for award of SRF provided Review Committee/ DRC finds her Research Progress satisfactory and recommends her case for award of SRF.

1.2 Fellowship Amount

1.3 Progress Evaluation of JRF/SRF : The award of fellowship shall be reviewed every semester based on the assessment of the Performance Report of the fellow by DRC. The DRC may recommend termination of the Fellowship in case the Performance Report of the Fellow is not found satisfactory consecutively for two semesters.

1.4 Upgradation of JRF to SRF: The progress of the JRF shall be reviewed after two years by the DRC / Review Committee constituted by the Vice Chancellor for consideration of upgradation of fellowship to SRF. The fellow may be given SRF after 2 years if the Review Committee / DRC finds that the fellow has done considerable research progress and recommends her case for upgradation to SRF. In case the Review Committee / DRC finds

the work progress / Performance Report of JRF not satisfactory, the committee can recommend for continuation of the fellow as JRF or can recommend termination of the fellowship. The recommendation of the Review Committee / DRC with subsequent approval by Vice Chancellor shall be the final decision.

1.5 Tenure of Fellowship: The tenure of fellowship is initially for two years under the JRF scheme. Upon expiry of this period, the work of the Fellow will be evaluated by experts. If the research work is found satisfactory, his/her tenure will be extended for a further period of three years under the enhanced emoluments of the Senior Research Fellowship (SRF). In case the work for the first two years is not found satisfactory, an additional year will be given to her for improvement. However, during this period she will be designated as a Junior Research Fellow. In such cases, work will be evaluated again after three years, and if progress is found satisfactory, the Fellow will get two more years under the SRF. Thus, the total period of fellowship (JRF and SRF) is five years and there is no further provision of extension.

1.6 All provisions of prevailing Ph.D. Ordinance/Regulations of IGDTUW shall be applicable on the JRFs/SRFs.

1.7 The JRFs/SRFs must submit a detailed consolidated report of the research work done during the entire period of Fellowship on completion of the tenure / resignation of the Fellowship to the Dean (R&C) at the earliest.

1.8 A JRF/SRF shall be governed by the disciplinary regulations of IGDTUW.

1.9 Sponsored students and students receiving any other financial assistance from any sources would not be eligible for fellowship under the IGDTUW JRF/SRF scheme.

1.10 The stipend of JRF/SRF is exempted from the payment of Income Tax under Section 10(16) of the Income Tax Act, 1961.

2.0 Service Conditions:

2.1 DA and CCA: The JRFs/SRFs will not be entitled to these allowances.

2.2 House Rent Allowance (HRA): JRFs/SRFs may be provided hostel accommodation if available and those residing in accommodation provided by the university will not be eligible for drawing HRA. Wherever provision of hostel accommodation is not possible, HRA may be allowed to the JRFs/SRFs as per the Government norms applicable in the city /location where they are working. The fellowship amount may be taken as basic for calculating the HRA

2.3 Leave Entitlement:

- i. A JRF/SRF will be entitled to avail leave for 30 days per academic year including medical leave. She will not be entitled to summer and winter vacations.
- ii. Leave beyond the stipulated period in an academic year may be granted in exceptional

cases, by the DRC for additional 30 days, on recommendation of supervisor. However, such an extension shall be granted only once during the entire programme of the Scholar.

- iii. The JRF/SRF will be eligible for Maternity Leave prescribed by Govt. of NCT of Delhi. The candidates getting fellowship will be eligible for Maternity Leave with fellowship as per rules and regulations prescribed by Govt. of NCT of Delhi.
- iv. The leave period shall be counted in the total period required for submission of the thesis stipulated in IGDTUW Ph.D Regulations.
- v. A JRF/SRF may be permitted to take a “**Semester Break**” on medical grounds with due recommendation of the supervisor and approval from the DRC. The leave period shall be counted in the total period required for submission of the thesis stipulated in IGDTUW Ph.D Regulations.
- vi. Participation by JRF/SRF in any scientific event/workshop in India or abroad will be treated as 'Duty'.
- vii. All leave record of JRFs/SRFs shall be maintained by the HOD office.

2.4 Bonus and Leave Travel Concessions: JRFs/ SRFs will not be entitled to these allowances.

2.5 Retirement Benefits: JRFs/ SRFs will not be entitled to these benefits.

2.6 The award of JRF/SRF shall not entitle the student to claim any right whatsoever for any job in the institution.

3.0 Obligations of JRF/SRF:

3.1 JRF/SRF shall be required to engage teaching/practical classes at IGDTUW for upto 08 hours /week or any other load assigned by the HOD. In addition, the JRF/SRF shall undertake other academic assignments such as examination, invigilation, evaluation etc.

3.2 The JRF/SRF shall pay the fee as per University norms.

3.3 The JRF/SRF shall mark their regular attendance in their Department.

3.4 The JRF/SRF shall not take any assignment paid or unpaid outside the university.

3.5 The JRF/SRF may present/publish their research work in conferences or standard referred journals. It should be ensured by the JRF/SRF that the assistance provided by IGDTUW is acknowledged in all such presentations/ publications. A copy each of all research papers published by the JRF/SRF must be sent to the office of Dean (R&C) at the end of each semester.

3.6 The JRF must send a detailed consolidated report of the research work done during the entire period of the fellowship on completion of the tenure/resignation of the fellowship through the supervisor/HOD to the office of Dean (R&C). The fellow should submit **NO DUES CERTIFICATE** through the supervisor/HOD after completion of the fellowship.

4.0 Resignation from Fellowship: If a JRF/SRF resigns from the fellowship due to any reasons, the fellowship shall be deemed withdrawn, however she may be allowed to continue as a Full Time Ph.D Scholar on the recommendation of DRC and subsequent approval of Vice Chancellor. The fellow may be allowed to convert to Part Time Research Scholar provided she fulfills the eligibility for conversion to Part Time as per Ph.D regulation R5.3

5.0 Termination of Fellowship

- (i) The fellowship shall normally stand terminated on completion of its tenure or from the date the JRF/SRF resigns. The Fellowship may be terminated by the University on the recommendation of the DRC.
- (ii) The fellowship may also be terminated on the following grounds :
 - (a) Disciplinary grounds/misconduct/Plagiarism Instance
 - (b) Unsatisfactory progress of research work for two consecutive semesters
 - (c) Candidate found ineligible for fellowship at any later stage shall deposit the entire fellowship amount claimed by the fellow in the university.
- (iii) The fellowship will be terminated from the date of submission of thesis for the award of Degree of Ph.D or on completion of fellowship tenure whichever is earlier.
- (iv) If a JRF/SRF leaves without permission at any time, she shall not be paid the fellowship for the period of her service till such time she gets a No Dues Certificate from the Head of the department.
- (v) Taking up of any paid assignment by JRF/SRF outside the university at any time in the tenure of fellowship, may lead to the termination of fellowship and the JRF/SRF shall be asked to pay back the entire fellowship amount.
- (vi) JRF/SRF must settle their claims within one year of leaving the Fellowship. No claim will be admitted by University after one year of leaving the Fellowship.

6.0 REIMBURSEMENT OF FELLOWSHIP

- (i) The JRF/SRF Fellowship Claim form in Annexure A shall be duly signed by the supervisor and countersigned by the HOD for reimbursement purpose.
- (ii) The JRF/SRF shall maintain a fellowship register for all fellowship claim purposes

Minutes of the meeting

The online meeting of the committee constituted for formulation the guidelines for various incentives/financial assistance to UG, PG and Ph.D students was held on May 18th, 2021 at 4:00 pm. The following members attended the meeting:

1. Prof. Ranu Gadi, Dean (R&C)
2. Prof. D.K. Tayal, Chief Proctor
3. Prof. S.R.N Reddy, Professor, CSE
4. Prof. Seeja K.R., HOD (CSE)
5. Dr. Richa Yadav, Assistant Prof., Coordinator (R&C), Special Invitee
6. Dr. Bhavani Prasad, Assistant Prof., Coordinator (IRD), Special Invitee

The Dean (R&C), IGDTUW welcomed the members and apprised them about following Incentives/ Financial Assistance to the students and formulation of detailed guidelines for (i) Financial assistance to Non-GATE M.Tech/M.Plan students (ii) monthly stipend to Full-time PhD Scholars and (iii) incentive to UG/PG students for publication of research article/paper in Journal.

1: Grant of Financial Assistance of Rs. 7,500/- per month with an upper limit of 10 students per branch to Non-GATE students pursuing M.Tech./M.Plan. Program based on their performance in the 1st semester from the Academic Year 2021-22 onwards. The shortlisted students will also contribute teaching assistantship of 4-6 hours per week.

Committee members deliberated on the eligibility criteria for giving this incentive to Non-GATE M.Tech students and gave the following recommendations:-

- I. The PG NON-GATE scholarship will be given from second semester onwards if a student gets a CGPA score of 8 or above [on a scale of 10]. Also, it will be mandatory for student to maintain the consistency in CGPA in the forthcoming semesters to get the stipend.
- II. The student getting the stipend would undertake 4-6 hours (per week) of work related to teaching and research activities as assigned to her by the institute. Stipend will be granted on monthly basis subjected to the satisfactory academic performance as certified by Head of Department and adherence to University rules and regulations as applicable times to time.

2: Grant of Monthly stipend of Rs. 10,000/- to full time Ph.D. Scholars who are not in receipt of any financial support from any source from the Academic Year 2021-22 from University Receipts for a period of five years from the date of admission to full time PhD Scholars from the Academic Year 2021-22. The full time Ph.D. Research Scholars getting the monthly stipend would also assist in Academic/Administrative work in their respective Department for 4-6 hours per week in addition to their research work.

In the interest of students and to attract more female students in STEM research with a low attrition rate, full time (FT) research scholars will be given stipend of Rs. 10,000/- per month from forthcoming Academic Year 2021-22, to sustain their day-to-day expenses during the PhD Programme. Deliberations were made on the guidelines to be formulated for giving monthly stipend to full time Ph.D Scholars and the following points were suggested:-

- I. Recommendation of Supervisor and concerned HoD will be included in the claim form which will be a feedback form/activity report. Supervisor and HoD will work in resonance to review the progress of performance of duties assigned to full-time Scholar and quality research done by her. In case the scholar is not performing well then, her case may be recommended for suspension of emoluments and her stipend shall be terminated on the recommendation of the HOD.
- II. Performance of FT scholar will be reviewed by HOD and Supervisor on the basis of parameters viz. research, teaching and administrative responsibilities handled by her.
- III. The Full Time PhD Students, who were enrolled prior to 2021-22, will be awarded monthly stipend of Rs 10,000/- for the balance number of years (counted only upto five years from the date of admission), provided they satisfy clause I & II above.


3: Award of incentive of Rs. 5,000/- and Rs. 10,000/- to UG/PG student for every publication of research article in SCOPUS and SCI/SCIE Index Journal respectively to boost the morale of the students and build research ecosystem in the University.

- I. In order to protect the welfare of our students and to boost the culture of research and promote excellence in R&D by publishing of good quality research papers in reputed Journals, Research awards have been already been incepted by the University. These awards are given to all the researchers of the University (including UG, PG, Ph.D Students) in the recognition of importance of their published research work and to motivate individual excellence in research.
- II. Committee members recommended that as this incentive to students has already been included in Research awards, therefore instead a scheme for an incentive to students may be initiated for Product development, the products which have been deployed and providing solutions to society. Department wise Committees may be constituted to evaluate these products.

Based on the recommendations of the Committee members the draft guidelines for the first two schemes have been formulated and attached as Annexure A and B.

Annexure-A

DRAFT GUIDELINES FOR POST-GRADUATE NON-GATE
FINANCIAL ASSISTANCE SCHEME (w.e.f 2021-22)

1. Objectives of the Scheme:

The financial Assistance scheme would help the students to sustain their expenses during the Post- Graduate Programme, thus reducing the financial constraints on the family of female students to complete their higher education. Further, this initiative would also contribute to the knowledge economy of the Nation, since the stipend would give a boost to attract more female students to the Post Graduate Programmes at IGDTUW.

2. Amount of Assistance:

The Stipend under the scheme is Rs. 7,500/- per month. The stipend would be granted to a maximum of ten students per batch for each branch based on their performance.

3. Duration:

The Stipend is tenable for 18 months or for the duration of the course from second semester onwards i.e. from the date of commencement of classes of second semester till the date of completion of the classes whichever is lower and is not extendable under any circumstances.

4. Eligibility for Scholarship:

Students of MTech and MPlan who are not eligible for GATE scholarship are entitled to PG Non-Gate Stipend from the second semester onwards in case they get a CGPA score of 8 or above (on a scale of 10) in their first semester. The student will have to maintain a CGPA score of 8 or above in subsequent semesters also. The stipend would be discontinued if the CGPA would fall below 8.

5. Terms and Conditions:

- i) In case any student receives any financial assistance from any other organization during the tenure of course, with due permission of the University, the student will not be entitled for the stipend for the duration in which she is availing such financial assistance and it shall be resumed on discontinuance of such external financial assistance. Further the period for which the student has received external financial assistance shall be deducted from the maximum duration of the assistance.
- ii) The student would have to undertake 4 to 6 hours (per week) of work related to teaching

and research activities as assigned to her by the Institute. This could include tutorials, lab.classes, development and maintenance of laboratories, assistance in research and development activities undertaken by faculty members, maintenance and operation of Central facilities etc.

- iii) The Stipend will be granted to the student on a monthly basis subject to the satisfactory academic performance and adherence to University norms/rules and regulations as applicable time to time, certified by the Head of the Department and Academic/administrative work as per point no (ii) above.
- iv) The student shall be required to give an undertaking to the effect that she would not leave the course midway. In case any student leaves the course in midway or failed/ drop out in subsequent year, she will be required to refund the total stipend drawn at the time of leaving the course.
- v) The Stipend may be discontinued at any time for any kind of misconduct by the student, like involving in the act of ragging, misbehavior etc.
- vi) Students are not entitled to House Rent Allowance (HRA) or any other benefits.
- vii) The monthly stipend would be exempted from the payment of Income Tax under Section 10(16) of the Income Tax Act, 1961.

Annexure-B

DRAFT GUIDELINES FOR STIPEND TO FULL TIME Ph.D SCHOLARS
(w.e.f. 2021-22)

1. Objectives of the Scheme:

To boost the culture of research and innovation, promote excellence in Research and Development and to attract more female students in STEM research with a low attrition rate. The financial Assistance scheme would help the students to sustain their day-to-day expenses during the PhD Programme, thus reducing the financial constraints on the family of female students to complete their PhD. Further, this initiative would also contribute to the knowledge economy of the Nation, since the stipend would give a boost to attract more female students of high calibre to the PhD programme at IGDTUW.

2. Amount of Assistance:

Monthly stipend of Rs. 10,000/- to full time Ph.D. Scholars who are not in receipt of any financial support from any source from the Academic Year 2021-22.

3. Duration:

The monthly stipend would be given to all Full-time Research Scholars for a maximum period of five years from the date of admission or till their completion of PhD, whichever is less and there is no further provision of extension. The scheme is applicable from Academic Year 2021-22.

4. Eligibility for Financial assistance:

Sponsored students and students receiving any other financial assistance from any sources would not be eligible for the scheme.

5. Terms and Conditions:

- i) In case any Research Scholar receives any financial assistance from any other organization during the tenure of course, with due permission of the University, the scholar will not be entitled for the Stipend for the duration in which she is availing such financial assistance and it shall be resumed on discontinuance of such external financial assistance. Further the period for which the Scholar has received external financial assistance shall be deducted from the maximum duration of the scheme.
- ii) The full time Ph.D. Research Scholars getting the monthly stipend would also assist

in Academic/Administrative work in their respective Department for 4-6 hours per week in addition to their research work. The Scholars shall also undertake other academic assignments such as examination, invigilation, evaluation etc.

- iii) The Stipend will be granted to the student on a monthly basis subject to the satisfactory academic performance and adherence to University norms/rules and regulations as applicable time to time, certified by the Head of the Department and obligatory work as per point no (ii) above.
- iv) The Stipend may be discontinued at any time for any kind of misconduct by the student, like involving in the act of ragging, misbehavior etc.
- v) Full-time scholars are not entitled to House Rent Allowance (HRA) or any other benefits.
- vi) All provisions of prevailing Ph.D. ordinance of the University shall be applicable on all Full-time PhD Scholars.
- vii) The monthly stipend would be exempted from the payment of Income Tax under Section 10(16) of the Income Tax Act, 1961.
- viii) The Stipend Claim form in Annexure-A shall be duly signed by the Supervisor and countersigned by the HOD for reimbursement purpose.
- ix) The Scholar shall maintain a register for all claim purposes.
