Circular

This is with reference to University Circular No. F. No.3 (9)/Admn/2015/IGDTUW/2032 dated 22.01.2024 vide which the Mandatory Teachers Training as mentioned at Clause 4.0 of AICTE Regulation, 2019 for Probation Confirmation/Grant of Promotion to teachers in technical discipline were circulated.

The Board of Management, IGDTUW has approved the adoption of AICTE Regulation-2019 in its 11th meeting held on 11.08.2020 vide Supplementary Agenda Item No. SA 11.01, on Minimum Qualifications for Appointment of Teachers and Other Academic Staff and Measures for the Maintenance of Standards of Higher Education in the University. As per the regulation, those who are eligible for promotions after notification of the regulation, shall have to meet the necessary conditions such as additional qualification, undergoing industrial training, pedagogical training, faculty induction program, publishing research papers etc.

The University vide above referred Circular dated 22.01.2024 has given the deadline of 31st July, 2024 for completion of the necessary conditions. It has been observed that the time provided to the teachers of the university after notification of the Circular Dated 22.01.2024 for completion of the Mandatory Teachers Training as mentioned at Clause 4.0 of AICTE Regulation, 2019 was very short period of only six months, which was not sufficient for the teachers of the university to register and complete the Mandatory Teachers Training.

In view of forgoing and AICTE clarification dated 09th Feb., 2024, a relaxation is given to the faculty members of IGDTUW to complete the Mandatory Teachers Training as per Clause 4.0 of AICTE Regulation, 2019 up to 31st December, 2025.
