**SPOT ROUND COUNSELLING FOR ADMISSION TO M.TECH
PROGRAM IN IGDTUW FOR THE ACADEMIC YEAR 2024-25
AGAINST THE VACANT SEATS**

Subject: Instructions for spot round counselling for admission to M.Tech Program, 2024-25 in IGDTUW, Delhi

1. Procedure Timeline:

1.1 Up-gradation of Allotted Branch (10:00 am to 12:30 pm, 13th August 2024)

1.2 Spot Admissions against vacant seats (1:30 pm to 4:30 pm, 13th August 2024)

All the participating candidates should report at 10:00 AM in the Room No. 209, First Floor, IT Department, IGDTUW, Kashmere Gate, Delhi – 1100 06. The spot round counselling will be conducted for admission to the M.Tech Program against the vacant seats.

2. Fee to be paid at the time of Admission:

Every candidate participating in the Spot Round of Counselling shall pay Rs. 1000/- as the Registration fee in the form of Demand Draft drawn in favour of “Registrar IGDTU for Women-Student Fee SB A/C” payable at New Delhi.

Every applicant who gets the admission offer in the M.Tech program in the spot round counselling shall pay the course Fee in the form of Demand Draft of Rs. 1,22,000/- (Rupees One Lakh Twenty-Two Thousand only) drawn in favour of “Registrar IGDTU for Women- Student Fee SB A/C” payable at New Delhi.

3. Withdrawal Policy

University Standard withdrawal policy will be applicable in line with the UGC norms.

4. The eligibility criteria remain same as published in the brochure. There is no change in the eligibility criteria in the spot round of counseling

5. Documents required at the time of Spot Round Counseling for M.Tech Programs 2024-25:

- Two passport size photographs.
- Original and self-attested copy of Identity proof (Aadhar Card/PAN Card/Driving Licence/Passport/Voter ID)
- Original and self-attested copy of class 10th certificate in support of Date of Birth.
- Original and self-attested copy of mark sheet of 12th class

- Original and self-attested copy of Mark sheet(s) and certificate of qualifying degree in support of verification of marks and Region.
 - Original and self-attested copy of GATE Score card (if applicable).
 - Proof of CGPA/SGPA conversion to Percentage (if applicable).
 - Original and self-attested copy for the category certificate (as applicable for SC/ST/OBC/KM/CW/EWS)
 - Medical fitness certificate in original.
- 6. Candidate will be eligible for final seat allotment subject to the following:**
- a) **Verification of all document at the time of counselling and fulfilling of the eligibility criteria**
 - b) **Availability of seat in the required field and payment of fee for the program**
7. If the candidate fails to produce any required document, her candidature is liable to be cancelled. In case, the candidate fails to fulfill minimum eligibility criteria, her admission shall be cancelled and no fee will be refunded. Admission may be cancelled even after seat allotment & submission of fee if any data/document provided by the applicant is found to be incorrect at some later stage.
