#### **ORDER**

Sub: Resumption of Biometric Cum Face Recognition Attendance in IGDTUW- regarding.

This has reference to University letter No. F. No. F.3(229)/Admn./Attendance/Bio-Metric/ Teaching/IGDTUW/2023/Pt. File/152 dated 08.05.2023 vide which order for resumption of Biometric cum Face Recognition Attendance for Faculty and Non-Faculty Staff Members, IGDTUW had issued. As per the said order, it was stipulated that:

All Faculty/Non-Faculty Staff Members are hereby directed to mark their attendance compulsory w.e.f. 15.05.2023 in Biometric Cum Face Recognition Attendance Machine installed at concerned departments. Further, it is advised that non-compliance of the order shall be observed adversely.

It has been brought to the notice of the Competent Authority, IGDTUW that a majority of the Faculty/Non-Faculty Staff Members have registered on the Biometric cum Face Recognition Attendance machines and started marking their attendance. However, a section of Faculty/Non-Faculty Staff Members has yet to register themselves on the Biometric cum Face Recognition Attendance machines installed in the respective workplace. Therefore, it is hereby reiterated that as per above referred order, registration in the Biometric cum Face Recognition Attendance machine is compulsory for every regular and contractual Faculty/Non-Faculty Staff Members, IGDTUW without any exception.

All such Faculty/Non- Faculty Staff Members, IGDTUW who have not yet complied with the instructions issued by the University are once again requested to register themselves in the Biometric cum Face Recognition Attendance machines and start marking attendance at once latest by 17.05.2023 failing which it shall be observed adversely.

This issues with the approval of Competent Authority, IGDTUW.
