

Issued for necessary compliance.





Subject: Proposals on foreign visits of Vice Chancellors of Universities.

Proposals regarding foreign visits in respect of Vice Chancellors and senior faculty of Universities under Govt. of NCT of Delhi are received in this Secretariat for consideration and approval of Hon'ble Lt. Governor.

- 2. Hon'ble Lt. Governor has observed with concern, that there is no uniformity in the channel of processing of these proposals. Further, some of these proposals are received very late.
- 3. In view of the above, Hon'ble Lt. Governor has desired that henceforth, all proposals regarding foreign visits of Vice Chancellors and the senior faculty of the Universities under Govt. of NCT of Delhi should be submitted necessarily through the concerned administrative department and these should be submitted to this Secretariat at least 2 weeks prior to the date of the proposed Visit. Also, details of foreign visits (private & official) undertaken in the last one year should also be mentioned in the proposal.
