1. Procedure Timeline:

1.1 Spot Admissions against vacant seats (11:00 am to 12:00 pm, 13th August, 2024)

All the participating candidates should report at 10:00 AM in the TNP Office IGDTUW, Kashmere Gate, Delhi – 1100 06. The spot round counseling will be conducted for admission to the B.Tech 2nd Year Lateral Entry 2024-25 against the vacant seats.

2. Fee to be paid at the time of Admission:

Every candidate participating in the Spot Round of Counseling shall pay Rs. 1000/- as the Registration fee in the form of Demand Draft drawn in favour of "Registrar IGDTUW-FEE ACCOUNT" payable at New Delhi.

Every applicant who gets the admission offer in the B.Tech 2nd Year Lateral Entry 2024-25 in the spot round counseling shall pay the course Fee in the form of Demand Draft of **Rs. 1,44,500/- (Rupees One Lakh Forty-Four Thousand Five Hundred only)** drawn in favour of "Registrar IGDTUW-FEE ACCOUNT" payable at New Delhi.

3. Withdrawal Policy

University Standard withdrawal policy will be applicable in line with the UGC norms.

- 4. The eligibility criteria remain same as published in the brochure. There is no change in the eligibility criteria in the spot round of counseling
- 5. Documents required at the time of Spot Round Counseling for B.Tech 2nd Year Lateral Entry 2024-25:
 - Print-out of the online application form duly signed by the candidate with four passport size photo.
 - 10th Class Certificate/equivalent (for Date of Birth proof).
 - Diploma marksheet Certificate.
 - Consolidated mark sheet for diploma & mark sheets of all years/semester for Diploma.

- Caste Certificate for SC/ST/OBC-NCL/EWS, if applicable. Candidates belonging to OBC-NCL & EWS will be required to submit the certificates issued on or later than 1st April, 2024.
- ID Proof Aadhar Card/Driving License/Voter ID/PAN CARD.
- Proof of CGPA/CPI conversion to percentage.
- Proof of payment of Rs. 1000/- as registration fee.
- Medical Fitness Certificate.
- Undertaking for Final Year Appearing Candidates. Candidates who are appearing in their final semester/final year examination (i.e. their qualifying degree result is awaited), have to fill the undertaking form.
- 6. Candidate will be eligible for final seat allotment subject to the following:
 - a) Verification of all document at the time of counseling and fulfilling of the eligibility criteria
 - b) Availability of seat in the required field and payment of fee for the program
- 7. If the candidate fails to produce any required document, her candidature is liable to be cancelled. In case, the candidate fails to fulfill minimum eligibility criteria, her admission shall be cancelled and no fee will be refunded. Admission may be cancelled even after seat allotment & submission of fee if any data/document provided by the applicant is found to be incorrect at some later stage.

Note:-

All the candidates hereby inform that the calling of candidates as per the above list is not the confirmation of the admission. It is only subject to availability of the seats in the respective departments. It is clarify that the seats will be allotted subject to vacant seats only.
